The KWOLF Kash / WILD Bills Giveaway Contest

HOW TO ENTER/WIN

Listen to KWOLF 98.1 & Wild 94.3 from May 14th to July 28th 2018. KWOLF & KWDD will give out KWOLF KASH & WILD BILLS (\$1000 bills funny money) on the air, and at announced locations in Fairbanks. Listen to the random announcements of what location KWOLF or WILD 94.3 is at and what time. Announcements will be made regarding the amounts of the KWOLF KASH & WILD BILLS to be given out at certain locations and certain times. KWOLF KASH & WILD BILLS is NOT REAL MONEY and has no cash value! From May 14th to July 28th 2018 KWOLF will be at announced locations. The object of the contest is to collect as much KWOLF KASH/WILD BILLS as possible over the specified dates above. Then on Saturday July 28th at 7pm at the Event Center will we have an auction.
